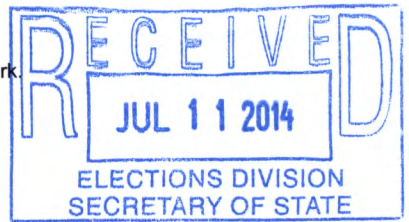

Empower PAC is established by Empower Mississippi (501c4) to support candidates that are committed to education choice, economic freedom, and fiscal responsibility.

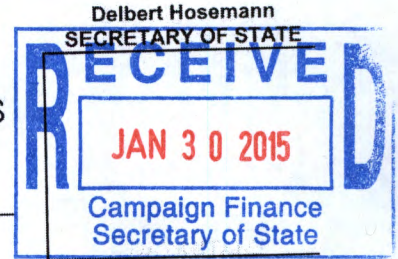
