That, RYAN JOSEPH PAVONE and MATTHEW ORLANDO WILBURN, late of the District, County and State aforesaid, on or about the 19th day of October in the year of our Lord, 2018, in the District, County and State aforesaid, and within the jurisdiction of this Court, did wilfully, unlawfully, feloniously, knowingly and intentionally possess with intent to sell, barter, transfer, distribute, or dispense a controlled substance, to-wit: Heroin, ten (10) grams or more, but less than thirty (30) grams, in direct violation of Section 41-29-139(a)(1), Mississippi Code 1972 Annotated, as amended, contrary to the form of the statute in such cases provided, and against the peace and dignity of the State of Mississippi.

#### COUNT 3

That, RYAN JOSEPH PAVONE and MATTHEW ORLANDO WILBURN, late of the District, County and State aforesaid, on or about the 19th day of October in the year of our Lord, 2018, in the District, County and State aforesaid, and within the jurisdiction of this Court, did wilfully, unlawfully, feloniously, knowingly and intentionally possess a controlled substance, to-wit: Cocaine, 0.1 gram or more but less than two (2) grams, in direct violation of Section 41-29-139(c), Mississippi Code 1972 Annotated, as amended, contrary to the form of the statute in such cases provided, and against the peace and dignity of the State of Mississippi.
