# ANSWER OF DEEP SOUTH TODAY d/b/a MISSISSIPPI TODAY AND MARY MARGARET WHITE TO COMPLAINT

COME NOW Defendants *Deep South Today* d/b/a *Mississippi Today* ("*Mississippi Today*") and Mary Margaret White and file this their Answer to the Complaint filed by Plaintiff Phil Bryant as follows:

#### FIRST DEFENSE

Plaintiff fails to state a claim upon which relief can be granted.

#### **SECOND DEFENSE**

Plaintiff is precluded from recovery by virtue of the First Amendment to the United States Constitution guaranteeing freedom of speech and the press.

#### THIRD DEFENSE

Plaintiff is precluded from recovery by virtue of Mississippi Constitution Article III, § 13 guaranteeing the right to free speech and the press and guaranteeing that free speech is a cherished right.

#### **FOURTH DEFENSE**

Section 95-1-5 Mississippi Code applies to this case.

## **FIFTH DEFENSE**

Defendant is free of any negligence.

#### SIXTH DEFENSE

The news story about which Plaintiffs complains involves issues of public interest and concern requiring Plaintiff to prove *New York Times v. Sullivan* malice by clear and convincing evidence, which as a matter of law, he cannot do.

### **SEVENTH DEFENSE**

Plaintiff is a public figure and was a public official, requiring him to prove *New York Times v. Sullivan* malice by clear and convincing evidence, which as a matter of law, he cannot do.

#### **EIGHTH DEFENSE**

Plaintiff is precluded from recovery by the Fair Comment Doctrine.

### **NINTH DEFENSE**

Plaintiff is precluded from recovery by the Neutral Reportage Doctrine.

#### TENTH DEFENSE

To the extent the speech about which Plaintiff complains is opinion, he is precluded from recovery.

## **ELEVENTH DEFENSE**

The publications about which Plaintiff complains are true or substantially true which precludes any recovery by Plaintiff.

#### TWELFTH DEFENSE

Any damages or injury about which Plaintiff complains was caused by or contributed to by Plaintiff or someone other than Defendants.

## THIRTEENTH DEFENSE

Plaintiff failed to mitigate any injury or damage about which he complains.

### **FOURTEENTH DEFENSE**

Section 85-5-7 Mississippi Code applies to this case.

#### FIFTEENTH DEFENSE

Plaintiff's claims are barred by applicable statutes of limitation, including § 15-1-35 Mississippi Code.

### SIXTEENTH DEFENSE

Plaintiff's claims are barred by the Single Instance Rule.

### **SEVENTEENTH DEFENSE**

Plaintiff's claims are barred by the Incremental Harm Doctrine.

### **EIGHTEENTH DEFENSE**

Plaintiff is not entitled to punitive damages.

#### NINETEENTH DEFENSE

Plaintiff is not entitled to presumed damages.

- 5.59 Defendants admit Mississippi has adopted § 95-1-5(2) Mississippi Code and would affirmatively show that *Mississippi Today* complied with that statute.
- 5.60 Defendants deny the allegations contained in Paragraph 5.60 of the Complaint.

# VIII. White, Ganucheau, and Wolfe violated Society of Professional Journalists' Code of Ethics.
