SENATE BILL NO. 2217

AN ACT TO DIRECT THE DEPARTMENT OF ARCHIVES AND HISTORY TO CAUSE THE DEPICTION OF THE CONFEDERATE FLAG TO BE REMOVED FROM THE STATE CAPITOL ROTUNDA; TO ESTABLISH A COMMISSION TO RECOMMEND A SUITABLE IMAGE TO REPLACE THE DEPICTION OF THE CONFEDERATE FLAG IN 5 THE CAPITOL ROTUNDA; TO PRESCRIBE THE MEMBERSHIP OF THE COMMISSION 6 AND TO PROVIDE FOR ITS ORGANIZATION AND MEETINGS; TO LIST THE 7 COMMISSION'S PREROGATIVES AND DUTIES; TO REQUIRE THE COMMISSION TO SUBMIT ITS WRITTEN RECOMMENDATION TO THE GOVERNOR AND THE 8 9 LEGISLATURE NO LATER THAN SEPTEMBER 30, 2024; TO PROVIDE FOR THE DISSOLUTION OF THE COMMISSION UPON THE SUBMISSION OF ITS WRITTEN 10 11 RECOMMENDATION; TO AMEND SECTION 55-15-81, MISSISSIPPI CODE OF 12 1972, WHICH PROHIBITS THE RELOCATION, REMOVAL, DISTURBING, 13 ALTERATION, RENAMING OR REDEDICATION OF CERTAIN HISTORICAL ITEMS, STRUCTURES OR AREAS, TO CONFORM; AND FOR RELATED PURPOSES. 14 15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** (1) As soon as practicable on or after the 16 17 effective date of this act, the Mississippi Department of Archives and History shall cause the depiction of the Confederate flag to 18 19 be removed from the State Capitol rotunda.

- 25 History, who shall serve as chair of the commission;
- 26 (b) Two (2) appointees of the Governor, to include:
- 27 (i) A representative from the Mississippi Economic
- 28 Council; and
- 29 (ii) A representative from the Mississippi Arts
- 30 Commission;
- 31 (c) Two (2) Senators, one (1) from each political
- 32 party, to be appointed by the Lieutenant Governor; and
- 33 (d) Two (2) Representatives, one (1) from each
- 34 political party, to be appointed by the Speaker of the House.
- 35 (3) All appointments to the commission shall be made no
- 36 later than June 30, 2024. As soon as practicable after all
- 37 appointments have been made, or as soon as practicable on or after
- 38 July 1, 2024, whichever is earlier, the commission shall meet upon
- 39 the call of the chair to organize and conduct business. A
- 40 majority of the commission shall constitute a quorum, and a
- 41 majority vote of the members present and voting shall be required
- 42 for any action by the commission. The Department of Archives and
- 43 History shall provide meeting space and clerical support for the
- 44 operation of the commission.
- 45 (4) The commission may:
- 46 (a) Hold regular public meetings when and where it sees
- 47 fit;

- 50 (c) Collect, examine and consider all information that
- 51 it determines may be helpful in making its recommendation;
- 52 (d) Consult with experts, representatives of
- 53 organizations and associations, and others, as it sees fit, whose
- 54 knowledge or expertise may assist the commission in making its
- 55 recommendation; and
- 56 (e) Make any inquiries and conduct any business that
- 57 may assist the commission in making its recommendation.
- 58 (5) The commission shall:
- 59 (a) Keep minutes of its meetings, and make those
- 60 minutes available to the public;
- 61 (b) When assessing options for an image to replace the
- 62 Confederate flag in the Capitol rotunda, give serious
- 63 consideration to a depiction of the slaves who contributed to the
- 64 construction of the State Capitol Building; and
- 65 (c) Submit its written recommendation to the Governor
- and the Legislature no later than September 30, 2024. Upon
- 67 submission of its written recommendation, the commission shall be
- 68 dissolved.
- 69 (6) Members of the commission shall receive no compensation
- 70 for their service on the commission, but they may receive
- 71 reimbursement for mileage and actual expenses as provided in

- 72 Section 25-3-41, to the extent that funds are available for that
- 73 purpose.
- 74 **SECTION 2.** Section 55-15-81, Mississippi Code of 1972, is
- 75 amended as follows:
- 76 55-15-81. (1) None of the following items, structures or
- 77 areas may be relocated, removed, disturbed, altered, renamed or
- 78 rededicated, unless specifically authorized or directed by an act
- 79 of the Legislature: Any Revolutionary War, War of 1812,
- 80 Mexican-American War, War Between the States, Spanish-American
- 81 War, World War I, World War II, Korean War, Vietnam War, Persian
- 82 Gulf War, War in Iraq or Native American War's statues, monuments,
- 83 memorials or nameplates (plaques), which have been erected on
- 84 public property of the state or any of its political subdivisions,
- 85 such as local, municipal or county owned public areas, and any
- 86 statues, monuments, memorials, nameplates (plagues), schools,
- 87 streets, bridges, buildings, parks preserves, reserves or other
- 88 public items, structure or areas of the state or any of its
- 89 political subdivisions, such as, local, municipal or county owned
- 90 public areas, which has been dedicated in memory of, or named for,
- 91 any historical military figure, historical military event,
- 92 military organization or military unit.
- 93 (2) No person may prevent the public body responsible for
- 94 maintaining any of the items, structures or areas described above
- 95 from taking proper measures and exercising proper means for the
- 96 protection, preservation, care, repair or restoration of those

- 98 memorial to a more suitable location if it is determined that the
- 99 location is more appropriate to displaying the monument.
- 100 (3) This section shall not apply to items, structures or
- 101 areas located on property owned or acquired by the Mississippi
- 102 Transportation Commission which may interfere with the
- 103 construction, maintenance or operation of public transportation
- 104 facilities.
- 105 **SECTION 3.** This act shall take effect and be in force from
- 106 and after July 1, 2024.
